



Trauma Documentation Tip:
When documenting the clinical findings of a gunshot wound, it is never advisable to label these injuries as "entrance" or "exit". The American College of Emergency Physicians (ACEP) recommends specialized forensic training to complete this assessment (Smock, 2022). As an alternative, ACEP

following:

- Shape
- Distinguishing forensic characteristics

# **Guilty Verdict: Elijah McClain Case**

On December 22<sup>nd</sup>, 2023, two paramedics in Aurora, Colorado were charged with criminally negligent homicide for their actions and inactions in the care of Elijah McClain. While any pre-hospital patient death is devastating, this case is particularly impactful to all those in the **Emergency Medical Services** community. The findings of this case will likely impact initial education, interprofessional collaboration, and protocols in the coming years. As we collectively begin to evaluate the case (pre-arrival details, care objectives, interprofessional information exchange, and ongoing observation), the Mclean County Area EMS System will continue to demonstrate our commitment to EMS providers across our service region by:

- Ensuring protocols match the national standard for patient care.
- Reviewing and updating policies that support interprofessional collaboration with defined roles in patient treatment & care.
- Providing continued opportunities for individual exploration of the case and associated outcome
